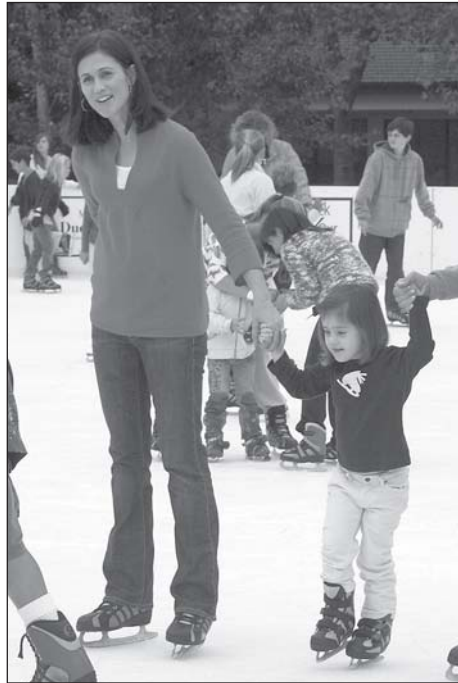
Join celebration of historic inauguration and get involved in 'Day of Service'

City manager's message

Say 'yes' to WC by buying here

I've been reminded recently what a really special place Walnut Creek is. As we've been celebrating Gwen Regalia's 21 years of service and Charlie Abrams's 12 years on the City Council, it reminds us of all the wise and selfless people who have gone before on our City Council.

I've been reflecting as well on the hard economic times we're in now. This certainly isn't the first time we've been through a tough financial period, and we'll get through it again, but we will have to make difficult decisions in the short run.

I've been struck recently, in talking with people, that many residents don't understand the connection between our downtown businesses and car dealerships and the quality of life we enjoy. People ask me: "Why does the City spend so much time focused on improving the downtown?"

The answer is simple: A strong local economy translates into jobs and sales tax revenue — the single largest source of income for our city government (about 34% of our revenue). Many people mistakenly believe property tax is the main income source, but the fact is that annual property tax revenue (about \$16.7 million) doesn't even cover the annual cost of police services (\$19.6 million).

So, as we struggle through this difficult economic time — in which people are not buying as many cars and trucks or generally shopping as much — we're

Neiman Marcus plan to be improved

The owners of Broadway Plaza plan to improve their proposal to bring Neiman Marcus into the shopping center to make it better for Walnut Creek citizens.

The City Council on Dec. 16 supported Macerich's request that the Council repeal the general plan amendment approved on Sept. 16. The vote was unanimous.

Macerich indicated it would bring back an improved proposal through the City's customary approval process or take it directly to voters as an initiative measure.

A petition signed by more than 5,800 citizens, challenging the validity of the general plan amendment, was submitted to

the City on Oct. 16. If Macerich had not chosen to revise its proposal, the Council would have had to either schedule a special election to allow voters to decide the fate of the Neiman Marcus proposal or repeal the general plan amendment.

In a Dec. 1 letter to the City Council, Macerich Executive Vice President John Genovese said the company conducted a poll in mid-November that "demonstrated both local support for the Neiman Marcus addition as well as some understandable community concerns. The results highlighted specific opportunities to

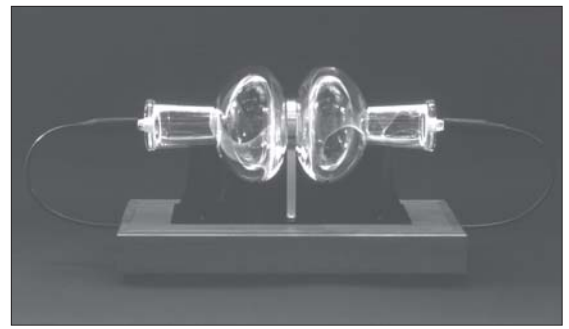
'Illuminated Sculpture' exhibition opens at Bedford

Lighting up the short, dark days of winter is an innovative exhibition, *Illuminated Sculpture*, at the City's Bedford Gallery, running from Jan. 11 through Feb. 22.

This luminous work is guest curated by Christian Schiess, an award-winning artist, author of *The Light Artist Anthology*, and Chair of the Light Art Department at the Bay Area's only nonprofit sculpture studio and educational foundry, The Crucible.

The artists in the exhibition use standard materials such as neon, argon, and electric light discharge as well as some of the emerging mediums such as LED's, electroluminescent wire, and photovoltaics.

Downtown library parking garage taking shape

Taking advantage of unseasonably dry autumn weather, construction workers in late November poured 760 tons of fresh concrete to create the floor of the underground, 121-space garage for the new downtown library at North Broadway and Lincoln Avenue.



Construction officials say the project is on schedule. The next major phase will begin in late February when the steel frame for the 42,000-square-foot library is built above the garage.

The library is scheduled to open in summer 2010.

CELEBRATING 30 YEARS OF SHELLIES

When the curtain came down on the very first Shellie Awards show back in February 1980, Scott Denison figured it would be the last time as well.

“I thought it would be a one-time event for people to dress up in their fancy clothes and celebrate and have fun,” said Denison, the creator and producer of the now-annual awards show. “But the actors wanted to continue the Shellies. They took it seriously. So it went to Year Number 2 and Year Number 3...”

On Jan. 17, the Shellies will complete its Year Number 30 on the Hofmann Theatre stage, where Denison will again orchestrate a gala celebration to honor outstanding achievement in performing arts in central Contra Costa County.

Denison, the energetic manager of the Lesher Center and a 35-year veteran of the City’s performing arts program, reflects on the beginning of the Shellies in his photo-studded office.

“I wanted to produce an awards program to highlight performing arts

activities in Contra Costa County,” said Denison, who has directed every Shellie Awards show. “Literally, the first night was just to celebrate and bring groups together to create a family.”

But what began in 1979 with a mere handful of regional theater groups, including Walnut Creek’s own Center Repertory company, has grown to 14 organizations who are happy to compete for the ceramic, hand-painted statuette of a harlequin that represents the best of Contra Costa theater. Nearly 800 Shellies have been handed out over the last 29 years, and there are 26 categories in which to compete.

Denison said the name “Shellie” is a take-off on walnut shell, and also a nod to the fact that when the actors are on stage, “they break out of their shell.”

“It’s a fun evening because you get a sampling of all the great shows that were produced in our area,” said Denison, noting each theater company will do a scene from a nominated show. “It’s very similar to the Tony Awards.”

Patrolling the streets of Walnut Creek

It's just another quiet Friday afternoon on the streets of Walnut Creek for Lt. Steve Skinner. The first call is from a local bank where a woman is attempting to pass a bad check. The next call is a report of a female motorist being repeatedly punched by a teenage male passenger as she drives down Ygnacio Valley Road. The third call is from a downtown drug store, where a man is causing a disturbance. And that's all just in the first half hour of the afternoon shift.

Lt. Skinner, a 21-year veteran of the Walnut Creek Police Department, quickly dispels what he says is the most common misconception about a patrol cop — that the officer is aimlessly driving around.

"The reality is that officers are on their way someplace," said Lt. Skinner, who is also a watch commander for the department. "The majority of the time, they're doing something — going to a call, seeing someone."

And although Lt. Skinner is the first to admit that Walnut Creek is a relatively safe

city to patrol, there is always the potential for injury or even death in the line of duty.

That explains the 223-calibre carbine rifle perched next to his car seat, and the .45 pistol, Taser, pepper spray, baton, and

handcuffs hanging from his 35-pound belt.

"It's something new everyday — you never know what could happen," he says. "The biggest thing we're always trying to get across to the public is that patrol cops really take their jobs seriously and they want to identify potential crooks and keep the streets safe."

The patrol car is literally the police officer's "roving office," as it is equipped with a two-way radio, a scanner, and a computer with fingerprints, Department of Motor Vehicle information, and mug shots.

The call suddenly comes in for a possible 5150 — that's cop talk for a person showing signs of mental instability.

Lt. Skinner and two other units arrive in front of Long's Drugs to confront a young man who had been yelling in front of the store. It takes about 20 minutes to determine why the man is acting irrationally and to resolve the situation.

"There's a lot of pride in this profession," says Lt. Skinner, adding he enjoys being on patrol. "You're out, dealing with people, solving problems. You do see a positive result for all your efforts."

600-pound Chinese warrior on duty in City Hall lobby

A life-size figure of a Xi'an Warrior, a gift to the City for the new downtown library from the Walnut Creek Chamber of Commerce and Leo Liu of the Inland Empire International Business Association, is now greeting visitors in the City Hall lobby. The sculpture, based on ancient figures buried centuries ago alongside China's first emperor, was cast in terra cotta from a mold of an original warrior in Xi'an, China. It will stand guard at City Hall until it can be moved to its permanent home in the library in 2010.



City Council Update

New mayor, mayor pro tem chosen

Gary Skrel, an eight-year veteran of the City Council, was selected by his colleagues to serve his second term as mayor of Walnut Creek on Dec. 2.

Skrel, who was mayor in 2005, is president of a consulting firm that specializes in planning and construction management.

Sue Rainey, who has been on the Council since 1997, was chosen as mayor pro tem for the new year.

Further study OK'd on JCC plan

The City Council on Nov. 18 unanimously voted to direct staff to continue processing the Contra Costa Jewish Community Center's application for a general plan amendment that would allow 80 apartment units on its property on Tice Valley Boulevard.

Following a two-hour public hearing, Council members agreed that more information about the impacts of the project was needed before a final decision could be made.

The JCC's original 2005 plan called for 138 units, but that was pared to 120 in 2006 following neighbors' complaints. The Council rejected that proposal in July 2007.

City cancels plan to extend downtown meter enforcement

City officials have decided not to make any changes to downtown parking meter enforcement after considering the concerns of business owners who believe this is not the time to extend meter hours.

Regalia, Abrams end City Council tenures

Gwen Regalia, who served as mayor of Walnut Creek more than anyone in City history, stepped down Dec. 2 after a historic run of 21 years on the City Council.

Fellow council member Charlie Abrams, who twice served as mayor during his 12 years on the Council, also retired from a career in public service that began in 1983.

Regalia served an unprecedented five terms as mayor, in 1991, 1996, 1999, 2003, and 2008. She was the 46th person to serve as mayor of Walnut Creek since it became a city in 1914. Since 1957, when the mayor position was first rotated among council members on an annual basis, she is the only person to serve a fourth and a fifth term in the post.

A 50-year resident of Walnut Creek, Regalia was formerly a member of the Walnut Creek School Board (1978-87) and president of the Association of Bay Area

Governments (2002-04).

"In the 21 years that I've been here," she told the audience on Dec. 2, "the bookends of my career have been the building of the Leshner Regional Center for the Arts and ... the building of the Walnut Creek Library — two grand gems in our arts and culture environment in this community."

Abrams, who served as mayor in 2000 and 2004, was first elected to the Council in 1996 after serving terms on the Transportation and Planning commissions.

A 20-year resident, Abrams owns a local traffic engineering firm.

Qualified borrowers can get low-interest home rehabilitation loans through City

The City of Walnut Creek has funding available for low- and moderate-income Walnut Creek homeowners who need repairs to their home.

The City offers low interest, deferred rehabilitation loans of up to \$60,000 and emergency repair grants up to \$10,000, approved on a case-by-case basis.

Eligible applicants must be within program income limits. Loan funds may be used for various improvements, but are required to fall under the category of health and safety, property maintenance, functional obsolescence, energy effi-

ciency, or removal of architectural barriers for the disabled.

Common repairs permitted under this loan program include, but are not limited to: new roofs and gutters, insulation, central heating, remodeled kitchens and baths, electrical and plumbing upgrades, painting, ramps, grab bars, and concrete or deck repair.

businesses.

Currently, parking meters only operate from 9 a.m. to 6 p.m., Monday-Saturday.

City Manager Gary Pokorny said that the City decided not to make any changes given downtown merchants' concerns about the difficult economy and their request that no changes be made in the meter hours.

The City may revisit the proposal at a future time when the local economy improves and if local businesses request it, he said.

The proposal originated from concerns that downtown business employees were monopolizing on-street parking spaces, thereby limiting the amount of parking available to customers.

Pokorny added that before any changes to meter operating hours will be considered in the future, the City will conduct an extensive public outreach effort to solicit the opinions of shoppers and downtown business owners.

Don't be a victim of identity theft

Identity theft occurs when a "crook" steals a piece of personal identifying information, which may include your name, address, date of birth, or social security number, to gain access to a person's financial accounts. Armed with this information, an identity thief may open new credit accounts, apply for loans, rent an apartment, or set up utilities in someone else's name.



Identity theft is the fastest growing crime in the US. There have been 27.3 million victims in the last five years. Why? Well, every credit card or loan you've applied for, or college you've attended, or job you've had, every magazine you've ever subscribed to may have your personal information which makes up countless databases that can be compromised.

Here are some tips to avoid becoming a victim:

- Promptly collect your mail after delivery.
- Deposit outgoing mail at the post office or give it directly to the mail carrier. NEVER give personal information to anyone over the phone unless you initiated the call or verified his or her identity and the validity of the call.
- Shred all financial paperwork.
- Get rid of extra credit cards.
- Beware of mail, phone, or internet solicitations disguised as promotions offering instant prizes designed to obtain your personal information.
- Be suspicious if the caller is being pushy and trying to force you into a quick decision. Remember, if it sounds too good to be true, it probably is!
- Watch your credit report and immediately report any suspicious activity. For more information, visit www.walnutcreekpd.com.

going to have to make some tough decisions on the levels of services we can provide. After all, the City of Walnut Creek exists largely as a service-providing agency, and those services — whether they be police or arts education — have a price tag.

We need to encourage people to shop in Walnut Creek and we need to help our auto dealers and Broadway Plaza to remain viable — both of which help to make the city a better place. If the retail core is strong, we can use the resulting revenue to maintain the City services and programs people value.

So as we make our way through the difficult months and years ahead, it's vital

that we come together as a community.

rethink our Neiman Marcus plan so that it makes greater sense to us, and particularly, for Walnut Creek residents."

The plan calls for putting Neiman Marcus in the space formerly occupied by David M Brian from 1983 until October.

In a related move, a lawsuit filed on Oct. 17 challenged the validity of the City's environmental review of the plan.

The Environmental Impact Report, also approved by the Council Sept. 16, showed that the new store would have no significant impacts on parking or traffic.

As part of the project, Macerich had proposed to improve parking and traffic conditions through a variety of measures, including providing off-site parking for employees, extending the hours of the free downtown shuttle, and making various traffic and pedestrian improvements.

"The lawsuit is completely without merit," said City Attorney Paul Valle-Riestra. "The City conducted an extremely thorough environmental analysis of this project and stands by the EIR."

Valle-Riestra added, "This appears to be an attempt funded by interests outside of the city that are determined to delay this project for reasons completely unrelated to the environment."
